A. Theater advertising with J.D. Hock - Stacy stated that the cost for advertising at the Family Theater with J.D. Hock would cost as follows:

\$150 a month at Tawas Theater \$150 a month at West Branch Theater \$80 at Oscoda Theater

These costs would be broken down into two weeks intervals. It would be done two weeks prior to auditions and two weeks prior to a show. Stacy and Jolene will do this project. Our ads will be a combination of images and short videos.
